
**Sub: - Mandatory e-filing of Central Excise and Service Tax statutory returns
w.e.f 01.10.2011 -reg**

Attention of the trade, industry and all concerned is invited to Ministry of Finance, Department of Revenue, Notification No. 43/2011-Service Tax dated 25th August, 2011 and Notification No.21 & 22-Central Excise both dated 14th September 2011 on -"Mandatory e-filing of Central Excise & Service Tax returns" and MOU between CBEC and ICAI& MOU between CBEC and ICWAI dated 31.03.2010 and 13.04.2010 respectively:-

In the wake of issuance of the above quoted Notifications and M.O.U.s every Central Excise & Service tax assessee shall file their periodical returns i.e. ER-1, 2, 3, 4, 5, 6, 7&8 and ST-3 respectively, as the case may be, with effect from 01.10.2011 electronically through ACES. This is a mandatory provision. The assessee who were earlier registered under SACER/SAPS and whose data had been migrated to ACES, are required to get TPIN and password from their respective Range officers so that they can get access to ACES and file their above mentioned returns. In other words the assessee who are not registered with ACES are required to get TPIN and password from their respective Range officers for operating in ACES.

If they have any difficulty in filing their returns, they can take the help of under-mentioned "Certified Facilitation Centers" who will provide services on payment of prescribed fee.
